### Speakers

#### **Becky Farley, PT, MS, Ph.D.**

Dr. Becky Farley has over 30 years' experience in neurorehabilitation and is currently the CEO/founder of the nonprofit Parkinson Wellness Recovery | PWR! as well as a physiology associate at the University of Arizona. Dr. Farley received a doctorate in neuroscience from the University of Arizona, a Master of Science in Physical Therapy from the University of North Carolina, and a Bachelor of Science in Physical Therapy from the University of Oklahoma.

#### **Robert Dickerman, D.O., Ph.D., FACOS**

Dr. Robert Dickerman is a spine fellowship-trained neurosurgeon with extensive training on conservative (nonsurgical) and surgical options for treating patients with acute spinal conditions. He is the director of neurosurgery at Presbyterian Hospital of Plano, is the director of spine surgery at Medical Center Frisco, and is an associate professor at The University of North Texas Health Science Center.

#### **Brent Masel, M.D.**

Dr. Brent Masel has more than 35 years of experience in the brain injury field and is a prominent figure in the areas of research, treatment and patient care. He is the executive vice president of medical affairs at the Centre for Neuro Skills in the Dallas/Forth Worth area, where he had served as medical director since 1994. A graduate of Loyola Medical School in Illinois, he completed an internship in neurology at the University of Texas Medical Branch at Galveston. He established a neurology practice and received certification from the Board of Psychiatry and Neurology in 1980.

#### **Omesh Singh, D.O.**

Dr. Omesh Singh offers extensive knowledge and a humanistic approach to internal medicine. He is the internal medicine director for the Centre for Neuro Skills' clinical facilities in Texas and serves as a primary care physician for patients, providing personalized specialized care. Dr. Singh is a graduate of Lake Erie College of Osteopathic Medicine in Erie, Pa.

#### **Bud Langham, PT, MBA**

As chief clinical officer for Encompass Home Health, Bud Langham is focused on improving clinical services and patient outcomes to ensure the company lives up to its mission statement of "A Better Way to Care." Langham has been with Encompass Health for eight years. He graduated from the University of Oklahoma Health Sciences Center in 1999 with a Bachelor of Science in Physical Therapy, then earned a Master of Business Administration from the OU Price College of Business in 2005.

### Objectives

Discuss the different ways in which patients and families adjust to neurological disabilities and describe how the treatment team can assist with obtaining rehabilitation outcomes.

Discuss the significance of how new research related to the cause and symptoms of Parkinson' disease may impact current rehabilitation paradigms. Summarize the basic and clinical research that supports exercise as medicine and discuss its clinical implications. Define barriers to implementing exercise as medicine and provide potential solutions.

Understand the medical issues following a traumatic brain injury, along with discussing their origins, diagnosis and treatment. Identify implications for treatment through reviewing recent clinical research on traumatic brain injuries.

Review classic clinical symptoms of cervical and thoracic myelopathy. Analyze case studies and exam findings, while discussing postoperative issues. Address key benefits of aggressive rehabilitation for this patient population.

Gain a better understanding of the physiology of mild cognitive impairment and dementia. Review statistics and trends, while gaining a better understanding of common barriers to care for patients with these deficits. Learn how to prepare staff for the dementia epidemic to come.

### Accreditation
